

PROTECTION OF PERSONAL DATA

What personal data collects BDM Grup Invest?

In order to access windowshelios.com, you do not need to provide us with any personal data. To the extent you wish to receive an offer for the products offered by the website, we may ask you for certain identification information or personal data. Personal data (as defined by Law No 677/2001 and Regulation 2016/679 / EU) refers to any information that can be used to personally identify you or to contact you online or offline. Personal information is collected only with your consent (for example, if you deliberately provide us with one of the online forms by participating in raffles and contests, by registering or signing up on HELIOS websites).

The types of information collected will vary depending on the activity and purpose of the collection. Personal information required may include: first and last name, e-mail address, home address, telephone number.

For what purpose are personal data used?

The data provided by the clients are strictly confidential, BDM Grup Invest undertakes in front of its users / clients not to provide this data to unauthorized third parties and to use them strictly for the business relationship between the client and BDM Grup Invest. According to the requirements of Law no. 677/2001 and the Regulation 2016/679 / EU on the Protection of Individuals about the Processing of Personal Data and the Free Movement of Data, BDM Grup Invest undertakes to manage safely and only in order to achieve the specified purposes personal data on which you provide us with.

We process your data for:

- 1. Fulfilling the obligations and rights deriving from the contract
- 2. Running some Helios activities as:
 - a. Direct marketing for your information on news, offers, product changes
 - b. Notification of terms, prices or other standard information
 - c. Analyze the product choices to give you exactly what interests you
 - d. Assessing your degree of satisfaction
 - e. Statistical reports without creating individual profiles by automatic methods

What security measures does BDM Group Invest use to protect your data?

BDM Grup Invest undertakes to apply, in relation to the personal data of its users / clients, adequate technical and organizational measures to protect personal data against accidental or unlawful destruction, loss, alteration, disclosure or unauthorized access, especially if the processing involves data transmission within a network, and against any other form of illegal processing.

What are your rights with respect to personal data processing?

Your rights as provided for by Law 677/2001 and Regulation 2016/679 / EU on the protection of individuals about the processing of personal data and the free movement of such data include:



Law 677/2001 offers you:

- 1. The right to obtain, on request and free of charge for a request per year, the confirmation that your data is processed by BDM Grup Invest;
- 2. The right to oppose at any time, for legitimate and legitimate reasons related to your situation, personal data that is intended to be processed, unless there are legal provisions to the contrary. In case of justified opposition, the processing will no longer concern the data concerned.
- 3. The right to oppose at any time, free of charge and without any justification, that the data you are targeting will be processed for marketing purposes;
- 4. The right to address to justice in case you have suffered injury as a result of the processing of your personal data;
- 5. Right to file a complaint with the supervisory authority if you believe that your data has not been processed in accordance with the law.

The EU Regulation gives you more rights as follows:

- 1. Right to access: You have the right to obtain confirmation from us that we process your data or not, and if we give you access to them as well as the processing methods
- 2. Portability: You can receive your data in a structured format and send it to another vendor
- 3. Right to opposition: You have the right to oppose data processing when it serves a public interest or legitimate interest.
- 4. Right to rectification: immediate correction of inaccurate data.
- 5. Right to erase: You have the right to delete your collected data when: it is no longer required from a contractual point of view, you have withdrawn your consent and there is no legal basis for processing, you oppose the processing, the data was collected illegally, the data must be deleted for compliance with a legal obligation, the collection was done with the provision of information society services
- 6. Right to restricted processing: You have the right to request at any time restriction of processing when: processing is illegal, but you do not want to delete them but only processing, the accuracy is contested, if we no longer need your data for processing but you ask them to defend a law in court if you oppose the processing for a period of time ascertaining whether the legitimate rights prevail over your rights.
